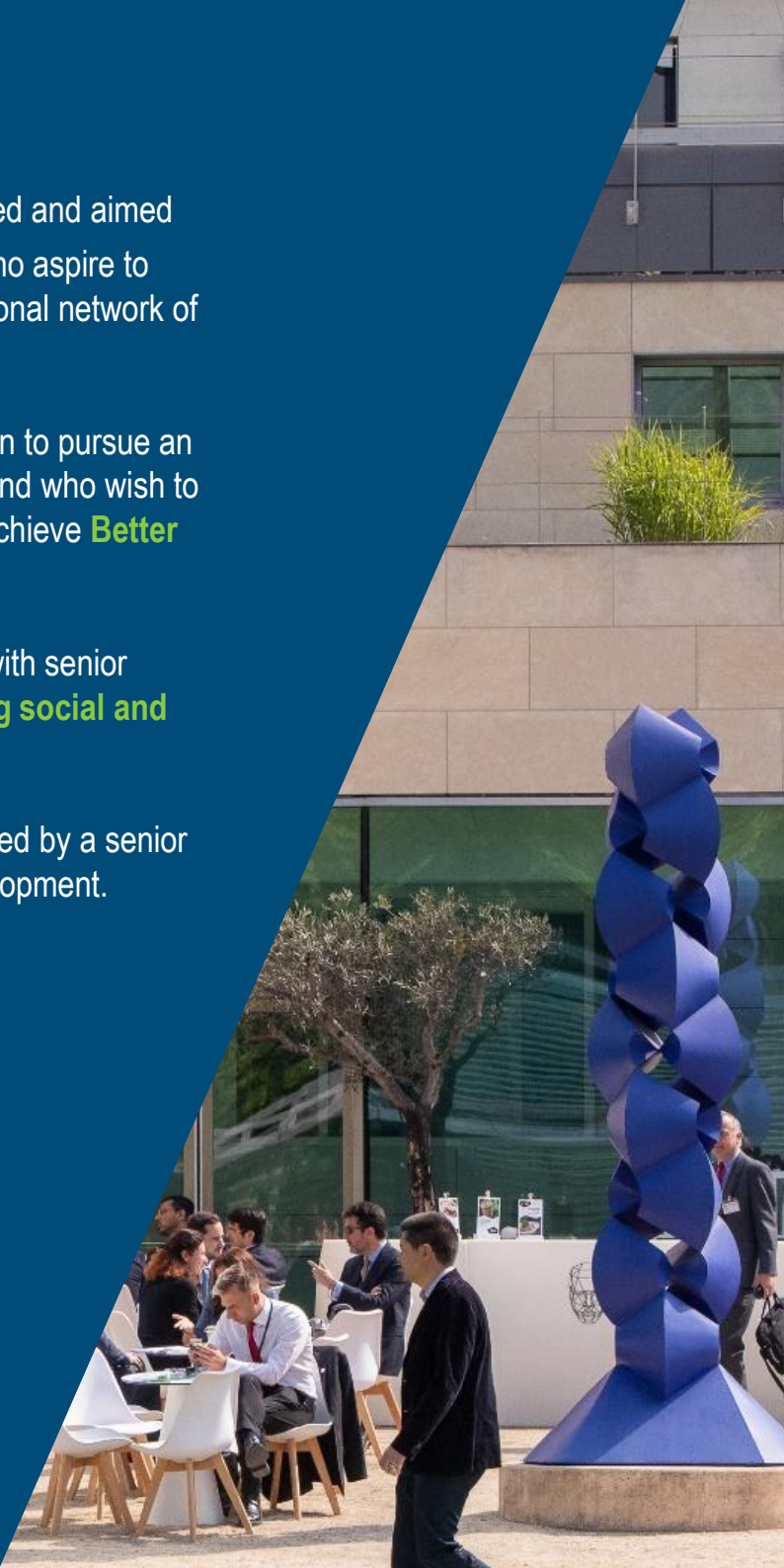
The OECD Young Associates

As a selected candidate, you will work closely with senior analysts tackling some of the **most challenging social and economic global issues** of today.

Throughout the Programme, you will be mentored by a senior manager who will guide your professional development.

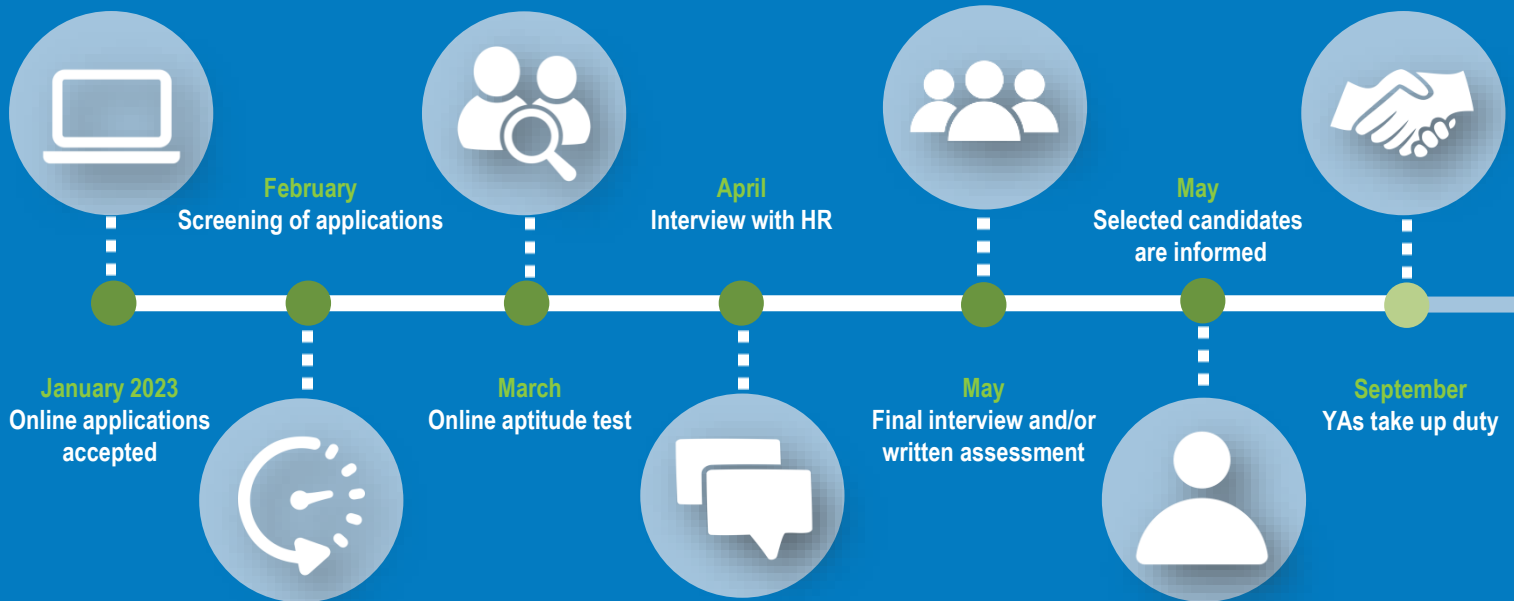
We look for candidates who:

- ✓ Hold a **nationality** of an OECD **Member country**;
- ✓ Have obtained or will obtain a **Bachelor's degree** between January 2022 and September 2023 (to be eligible, candidates may **NOT** hold or be enrolled in a Master's or PhD);
- ✓ Demonstrate a record of **strong academic achievement** with a minimum Grade Point Average (GPA) of 3.0 out of a 4.0 scale*;
- ✓ Have **fluency in one of the two OECD official languages** (English and French) and a commitment to reach a good working level of the other;
- ✓ Demonstrate the ability to **contribute** as a YA **in the area of work**, as well as demonstrate motivation to **pursue a graduate degree** in a relevant field after completing the Programme.
- ✓ Can start the Programme in **September 2023** for the two-year assignment.

During the two-year Programme, YAs are closely mentored by their managers to develop their substantive expertise and support their integration into the wider Division and Directorate.



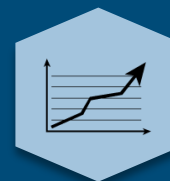

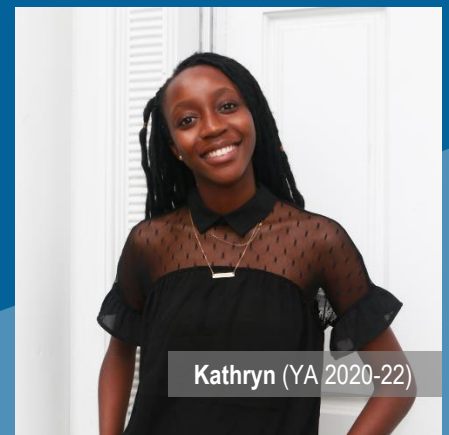
